

International study trip

People of many nationalities

Culturally diverse participants (with 7 nationalities in the 2022 cohort) learn a lot from each other and from EMBA professors with global experience who currently come from 17 countries of origin.

Practical Learning

The International Executive MBA develops a systematic grasp of all the pieces of the business puzzle so you can confidently make management decisions across the different functional areas.

The programme anchors learning to the real world and to each participant's own professional context.

Modules progress logically, with a hands-on executive approach.





Field Seminars

An up-close look at a specific current area of business opportunities. Includes focused lectures, site visits, expert panels and executive briefings.

Participants currently have a choice of:

- "Doing Business in the EU", in Brussels, the heart of Europe.

Live Projects

Teams apply recent learning to a real company, usually one where a participant works. They must develop solutions and present them convincingly to a jury of academics and businesspeople.

Capstone Project

In this final task of the EMBA, participants

- address a strategic issue at their own company or a client company, or
- develop a new venture, start-up or takeover project.

They integrate knowledge and tools from the programme to develop and defend recommendations on an issue of strategic importance. While demonstrating their executive ability, they create value for personally relevant real organizations.


